CANBERRA BURNS CLUB – PROPOSED AMENDMENTS TO THE CONSTITUTION FOR CONSIDERATION AT 2023 ANNUAL GENERAL MEETING

Background

The Burns Club Board decided earlier in 2023 to purchase Brindabella Golf Club, trading as Magpies Golf Club Belconnen. This was done primarily to diversify the members offering, broaden the audience to which to market to and follow the population growth forecast for that area.

In so doing a review of the current constitution was required resulting in some small amendments proposed by the Board. The amendments of an updated Constitution which the Board is proposing be considered and adopted at the 2023 Annual General Meeting.

The changes made as a result of the review primarily involve a combination of the following;

- acknowledging language formally used to represent the singular now means plural
- In general terms, whenever the term Club is used it is to represent both ClubS.
- Remove the need for the club to notify each member in writing of their pending expiry. This
 is necessary due to the costs associated with having to directly mail correspondence to each
 individual member. A member simply renews upon entering the club upon their next visit
 post.

Principal Changes

- 1. **DEFINITIONS** amend (iv) "Club" means THE CANBERRA HIGHLAND SOCIETY AND BURNS CLUB LIMITED, to "Club" means THE CANBERRA HIGHLAND SOCIETY AND BURNS CLUB LIMITED and all other ancillary Clubs.
- **2. MEMBERS SUBSCRIPTIONS** amend 10.11.4 by deleting "If so, the relevant member shall be notified in writing of the date on which the Annual Subscription is due to the Club."
